Directions to the Event Site

From the South: I-79 North to Exit 14 (Waynesburg). At the bottom of the Exit make a right onto Rt. 21 West. Show grounds are 6/10th of a mile on right.

From the North: I-79 South to Exit 14 (Waynesburg). At the bottom of the Exit make a right onto Rt. 21 West. Show grounds are 6/10th of a mile on right.

There will be a \$3.00 parking charge (or \$10 for all 4 days) for all vehicles entering the show on Thursday, Friday, Saturday, and Sunday

Directions for On Call Veterinarian: Follow race track around to the stable side until you get to an exit. That exit is Rt. 188. Make a right hand turn onto Rt. 188 East. Follow 188 for 2.1 miles. Braden Run Animal Hospital has a large sign on the right side of the road. Turn left immediately following the sign. That is Braden Run Road. Follow it for 0.6 mile. The animal hospital is on your left.

**** Mention that you are with the dog show to get their regular client discount on an emergency call.*

Directions for After Hours Veterinarian: Located off I-79, Exit 139 (Prickett's Fort). Southbound traffic turns right at the end of the exit ramp and the clinic is on the hill above the Exxon Station.
