From the South: I-79 North to Exit 14 (Waynesburg). At the bottom of the Exit make a right onto Rt. 21 West. Show grounds are 6/10th of a mile on right.

From the North: I-79 South to Exit 14 (Waynesburg). At the bottom of the Exit make a right onto Rt. 21 West. Show grounds are 6/10th of a mile on right.
